To understand the extent to which VMOs implemented nutritional standards as intended, compliance of vending machine products was monitored through photos taken during site visits. The following tables detail the planograms which were used to visualise product offerings in vending machines across pilot sites and analyse compliance with nutritional standards (FSA standards for PS1 and HSC standards for PS2 and PS3) post-implementation.
